## **OFFICIAL SERVICE CONTRACTORS**

The National Marine Manufacturers Association (NMMA), acting on behalf of all exhibitors has appointed official service contractors to perform and provide necessary services and equipment.

## **EXHIBITOR APPOINTED CONTRACTORS/THIRD PARTY REGISTRATION**

Any exhibitor using a contract other than an “**official service contractor**” listed under the Service Providers in the exhibitor kit, must submit the EAC/Third Party Registration form no later than December 1, 2017. Additionally, the required **Certificate of Insurance** from your appointed contractor must be forwarded along with the EAC/Third Party Registration form. EAC/Third Party registration fee is **\$1,000.00 by December 1, 2017** and **\$1,200.00 on/after December 2, 2017** must be paid prior to ordering credentials or performing any work on-site. Please be sure to notify your EAC/Third Party of all move-in / move-out (freight and/or boat target times) assigned schedules your company must meet. Any delays caused by your EAC/Third Party will be billed to your company.

Submit EAC/Third Party **Certificate of Insurance**, naming the **National Marine Manufacturers Association, City of Miami, and Expo Convention Contractors, Inc., as additionally insured** with the following limits: Commercial General Liability coverage including contractual liability coverage of at least **\$1,000,000.00** per occurrence and **\$1,000,000.00** aggregate. Statutory Worker’s Compensation with Employer’s Liability coverage in accordance with statutory regulation of the State of Florida.

## **EXCLUSIVE CONTRACTORS**

For insurance, safety, security and City of Miami ordinance requirements, the contractor designated by NMMA show management must be used for services such as catering, drayage, electrical, plumbing, rigging, telecommunications, tents, floral, booth cleaning/trash removal and security - NO exceptions will be made.
